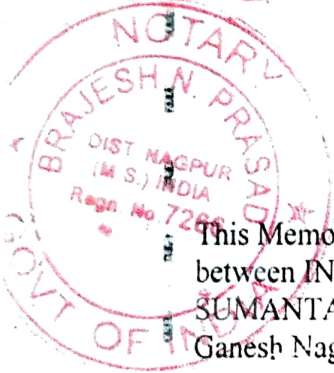

AND

Kims Kingsway Hospitals, a Unit of SPANV Medisearch Lifesciences Pvt Ltd, a company incorporated under the provisions of the Company Act, 2013 and having its registered office at 44, Parwana Bhawan, Kims Kingsway, Nagpur – 440001, Maharashtra hereinafter referred by its brand name Kims Kingsway Hospitals on the OTHER PART

Whereas Sumantai Wasnik Institute of Nursing, Nursing, Shivpriya Nagar, Opp. Ganesh Nagar, Dabha, Nagpur affiliated to Maharashtra University of Health Sciences, Nashik recognized by Indian Nursing Council, New Delhi and Maharashtra Nursing Council, Mumbai has asked for Clinical Training of its Basic B. The terms and conditions of the agreement will be as given below:

1. The agreement will be valid for a period of 5 (Five) Year from the date of this agreement. Subject to renewal after every academic year.
2. The institute will utilize the hospital facility for clinical training of its students throughout each academic year.
3. No patient details will be used for any other purpose other than the academic use of students of the institute. The clinical training in no way should harm any admitted patient or cause any discomfort of any nature to the patient.
4. The confidentiality of patients and patient's rights should be adhered to during the course of students training.
5. The students will have to abide by the code of conduct of the hospital.
6. The hospital reserves the right to discontinue any student and take disciplinary action as deemed fit for any action of misconduct performed by the student during the course of training at Kims Kingsway Hospitals, Nagpur.

8. The students will be posted at the hospital with prior information on the number of students being sent in the batch.
9. The institute shall pay Rs.300/- (Rupees Three Hundred Only) per student per month to the hospital for Clinical Training and Rs. 200/- (Rs. Two Hundred only) per student for practical exam. The institute shall deposit such fees with the hospital for sending such students for training.
